






Saturation Characteristics


Transfer Characteristics






R_{DS(on)}vs.Drain Current

R_{DS(on)}vs.Junction Temperature







Body-Diode Characteristics


Capacitance Characteristics






V_{GS(TH)} vs. Junction Temperature






Maximum Safe Operating Area

Single Pulse Power Rating, Junction-to-Case










