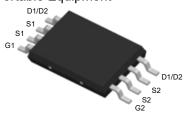

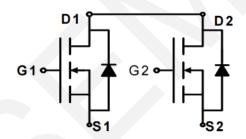

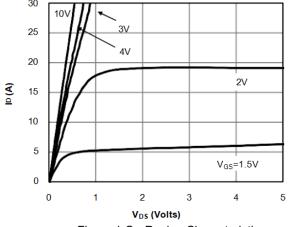


Figure 1 On-Region Characteristics

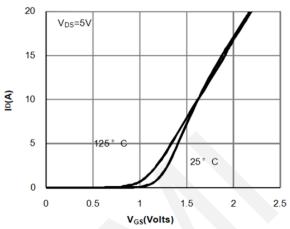


Figure 2 Transfer Characteristics

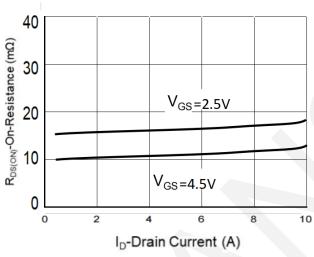


Figure 3 On-Resistance vs. Drain

Current and Gate Voltage

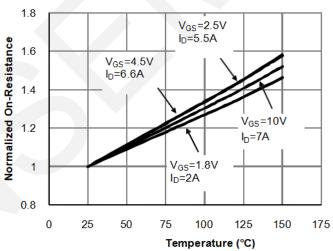


Figure 4 On-Resistance vs. Junction Temperature

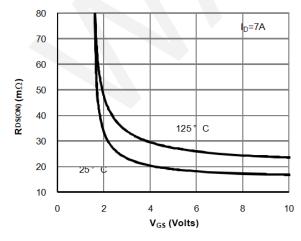


Figure 5 On-Resistance vs. Gate-Source Voltage

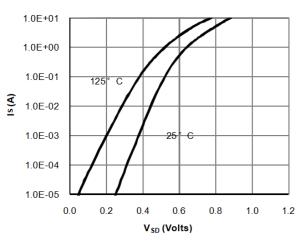
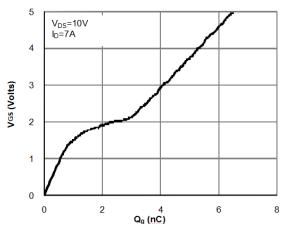


Figure 6 Body-Diode Characteristics





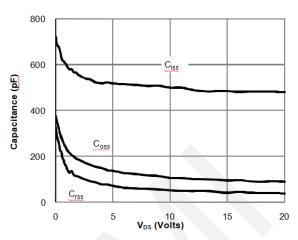
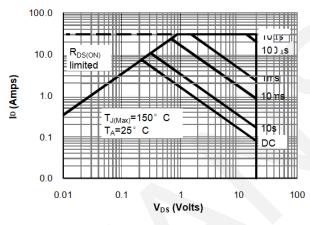


Figure 7 Gate-Charge Characteristics

Figure 8 Capacitance Characteristics



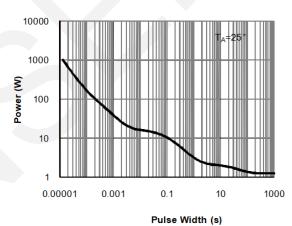


Figure 9 Safe Operating Area

Figure 10 Single Pulse Power Rating Junction-to- Ambient

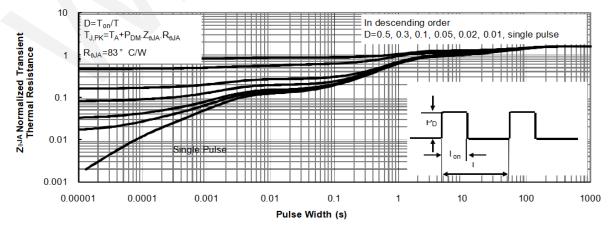
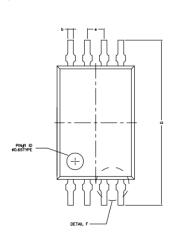
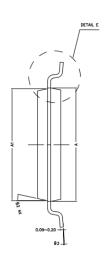


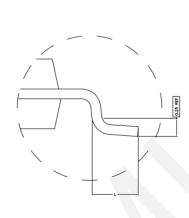
Figure 11 Maximum Transient Thermal Impedence



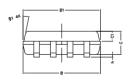
