









Output Characteristics




Typical Transfer Characteristics



On-resistance vs. Drain Current




Body Diode Characteristics




Gate Charge Characteristics

Capacitance Characteristics







Single Pulse Power Rating, Junction-to-Case



Normalized on Resistance vs.




Maximum Safe Operating Area



Maximum Continuous Drain Current vs.







Maximum Effective Transient


Thermal Impedance, Junction-to-Case
